A. Application Deadline: August 1, 2023

CRIMINAL JUSTICE PRACTICUM (PHILADELPHIA LAWYERS FOR SOCIAL EQUITY)

There are two slots available for second- and third-year law students in this Practicum supervised by Associate Dean Kristen Murray.

Philadelphia Lawyers for Social Equity (PLSE) offers free legal representation to low-income clients who are trying to clear their criminal records so they can qualify for better jobs, housing, credit, and other benefits. (By way of background, if someone is arrested in Pennsylvania and charged with a crime, even they never had to attend court or were later found not guilty after a trial, or anything in between, they still have a criminal record. Unless it is sealed or a judge orders it to be erased or expunged, that criminal record is permanently available on the internet to the public. The only way to get a conviction off your record, even if it was committed decades ago, is to get a pardon from the Governor of Pennsylvania.) Through its Criminal Record Expungement Project, PLSE files petitions for expungement that, after a hearing, could result in a judicial order that commands the City and State police and other agencies to remove the information of that person's criminal history from their record. PLSE files over 2,400 expungement petitions per year. Additionally, PLSE has a growing community education and outreach program.

In this Practicum, students will have a range of duties, with tasks varying week to week. Students will conduct intakes at community clinics and on the phone, draft and review expungement petitions, inform clients about updates in their case, and accompany the attorney to court. Students who are certified legal interns under Rules 321 or 322 of the Pennsylvania Supreme Court may have the opportunity to argue motions for expungement in court. Students will conduct research and write legal memoranda. There will be opportunities for public speaking and community presentations, as well as attending and tabling at community events. Students will have an opportunity to have a hand in their rapidly evolving pardon project and help develop the curriculum. PLSE is a rapidly growing small organization, and as such, there are constantly evolving projects that require creativity, flexibility, and initiative.

This Practicum is ideal for students with an interest in criminal justice, public policy, and public interest. Students must commit at least 10 hours a week to this Practicum. The experiential component of this Practicum will be in-person. CRIMINAL JUSTICE POLICY PRACTICUM (PUBLIC DEFENDERS ASSOCIATION OF PENNSYLVANIA)

There is one slot available for second-, third-, or fourth-year law students in this Practicum.

The experiential learning project offered with this Practicum is with the Public Defender

Association of Pennsylvania (PDAP), a non-profit corporation whose membership is comprised of the 600 or so public defenders employed full or part time in Pennsylvania's 67 county public defender offices of this Commonwealth. Incorporated in 1971, PDAP is a statewide community of public defenders dedicated to securing a fair justice system and ensuring high quality legal representation for people facing loss of life, freedom or family. Its mission is to provide tools, strategies, mutual support, training and information to Public Defender Offices in Pennsylvania; to be the voice of public defense in Pennsylvania; and to promote best practices in the leadership, management, and administration of justice in Pennsylvania.

In this Practicum, students will work to support and build community for Pennsylvania's Public Defenders by engaging in some or all of the following:

- Tracking and summarizing Pennsylvania legislation related to the crimes code and criminal justice
- Participating and supporting the effort to secure funding from the state for Pennsylvania's Public Defenders, including research on indigent defense funding and the cost of wrongful convictions, preparing for and attending meetings with state legislators, and assisting with communications outreach to state legislators
- Expanding and facilitating communications campaigns to Public Defenders across Pennsylvania, including website review, working with committees and working groups of Public Defenders from across the state, and preparing communications for Public Defenders across Pennsylvania
- Supporting training initiatives for Public Defenders, including updating training materials and logistical help with training conferences

This Practicum is ideal for law students who are committed to, or interested in learning more about, a career as a public defender or criminal justice law and policy. ENTREPRENEURIAL PRACTICUM (ROBIN HOOD VENTURES)

There is one slot for a second-, third-, or fourth-year law student in this practicum supervised by Professor Jonathan Lipson.

The experiential learning project offered with this Practicum is with Robin Hood Ventures, one of Philadelphia's largest angel investing groups.

In this Practicum, students will assist the group with: performing pre-investment due diligence on applicant companies in support of, and at the guidance of, RHV's investor-led due diligence teams; producing post-deal closing binders, investment summaries/updates, and tracking material terms of existing deals such as warrant expiration dates, etc.; and attending monthly investor meetings.

This Practicum is ideal for law students who are interested in the entrepreneurial space, the capital

markets space, and/or general transactional work.

Students will need to commit to 6.5 hours per week for 2 credits or 10 hours a week for 3 credits depending upon student preference. EMERGING TECHNOLOGIES AND INTERNATIONAL HUMAN RIGHTS ADVOCACY PRACTICUM (in collaboration with iLIT, Temple’s Institute on Law, Innovation & Technology)

There are up to two slots available for Fall 2023 in this practicum supervised by iLIT Executive Director Laura Bingham and Professor Salil Mehra. This practicum will be 10 hours per week for 3 credit hours. It is open to 2Ls, 3Ls, and 4L Evening Division students.

The experiential learning project offered with this practicum is with the Open Society Foundation’s Justice Initiative and Global Digital Identification Initiative. Both units are strategic partners within of one of the world’s largest philanthropic networks which also engages in direct policy advocacy, litigation, and strategic communications in line with its mission and goals.

This practicum will support current and developing interventions related to governance of emerging technologies such as artificial intelligence, biometric identification, and migration surveillance. Students will gain exposure to pressing national and global policy debates through direct engagement in support of ongoing transnational litigation, industry research, and broader normative processes concerning the governance and regulation of emerging technologies.

In light of the multidimensional nature of the work undertaken in the practicum, we are seeking enrollment from students with a range of experience and diverse academic and professional interests. The practicum offers the opportunity to learn about the design, implementation and emerging accountability frameworks governing new technologies, international human rights litigation in practice, and the field of philanthropy.

CRIMINAL LAW PRACTICUM (PHILADELPHIA DISTRICT ATTORNEY’S OFFICE LAW DIVISION)

There are multiple slots for second-, third-, and fourth-year law students in this Practicum.

The experiential learning project offered with this Practicum is with the Philadelphia District Attorney’s Office, the largest Prosecutor’s office in Pennsylvania, and one of the largest in the nation. The District Attorney’s Office is responsible for prosecution of over 50,000 criminal cases yearly. In this Practicum, students will have the opportunity to work in the Appeals Unit, the PCRA Unit, or the Federal Litigation Unit. Students in the Appeals Unit will research, write, and edit post-conviction appellate briefs to be filed in the Pennsylvania Superior Court. Students in the PCRA Unit will research, write, and edit responses to Post-Conviction Relief Act petitions and assist ADAs with preparing for evidentiary hearings. Students in the Federal Litigation Unit will assist

ADAs in responding to federal habeas petitions, including conducting relevant legal research and drafting and editing federal filings.

Students will need to commit to 10 hours a week for this three-credit practicum. ENVIRONMENTAL LAW PRACTICUM (DELAWARE RIVERKEEPER NETWORK)

There are up to two slots available for second- and third-year law students in this Practicum supervised by Professor Amy Sinden.

The experiential component of this three-credit Practicum is designed to expose students to the broad intersection of litigation, transactional work, policy, advocacy and work with grass-roots organizations. It provides a specialized and unique course of study focused on the local region's natural heritage, practical legal skills, and special issues and pitfalls in environmental law. In conjunction with this placement, students will work closely with the Delaware Riverkeeper as well as the senior and staff attorneys of the Delaware Riverkeeper Network to provide legal support to environmental professionals and citizens to help effectively protect our environment and communities through compliance with the federal, state, and local environmental laws and regulations. Under the supervision and guidance of the senior and staff attorneys, students will be expected to act as junior staff attorneys – perform legal research; draft strategy memoranda, pleadings, briefs and other legal documents for timely filing with courts and other government agencies; and write and present comments and testimony before bodies considering proposals that will affect the environment.

Please note that the experiential hours of this practicum may be completed remotely or in-person (to be determined between you and the practicum). Any in-person experiential hours will be held at the Delaware Riverkeeper Network, which is located at 925 Canal Street in Bristol, Pennsylvania, directly across from the Bristol train station (SEPTA Trenton Line) and has ample parking.

This Practicum is ideal for students who are committed to, or interested in learning more about, a career in environmental law, or students who want to gain writing experience. Students must complete a minimum of 10 hours each week of the semester of experiential work, classroom learning, or out of class assignments. Preference will be given to students who have taken, or will take concurrently, Environmental Law and Natural Resources. DOMESTIC VIOLENCE PRACTICUM (WOMEN AGAINST ABUSE)

There is one slot available for second- and third-year law students in this Practicum supervised by Professor Sarah Katz.

The experiential learning project offered with this Practicum is with Women Against Abuse (WAA). WAA is a nonprofit agency that provides comprehensive services for victims of domestic violence in Philadelphia. WAA provides services that include emergency safe haven, transitional housing, legal services, behavioral healthcare, hotline counseling, community education, and advocacy. With regard to legal representation, WAA engages in intake and direct advocacy. Each year approximately 12,000 petitions for protection from abuse orders are filed in Philadelphia. The majority of individuals seeking a protection from abuse order are unable to procure an attorney and must navigate complex legal processes on their own. In addition, many petitioners face escalating threats from an abuser to drop their case. Consequently, less than one third of petitioners obtain a final order of protection.

Students will spend the first semester focused on Protection from Abuse cases, developing client interviewing and counseling skills, engaging in case analysis, and assisting in preparing cases for litigation. Students that participate in the year-long practicum will expand their work in the second semester to additionally focus on child custody, child support, and spousal support cases, will lead their own intakes, and prepare their own case reviews. Throughout the practicum, students will shadow attorneys at court, complete legal research and analysis as needed, contribute to policy research as needed, and attend various trauma informed trainings through the Pennsylvania Coalition for Domestic Violence.

This Practicum is ideal for law students who are committed to, or interested in learning more about, a career advocating on behalf of domestic violence survivors, or a career in family law, public interest law, or criminal prosecution. Students will need to commit 12 to 14 hours per week. Preference will be given to students with an expressed interest in working with WAA for the entire academic year. EMPLOYMENT LAW PRACTICUM (EMPLOYMENT ADVOCACY PROJECT)

There are up to two slots available for second- and third-year full-time students in this Practicum.

The experiential learning project offered with this Practicum is with the Employment Advocacy Project, a project of Philadelphia Legal Assistance. EAP provides direct representation to clients who have had their Unemployment Compensation Benefits denied or contested.

In this Practicum, students will interview clients, build legal strategies, meet with clients in person to discuss the strategy and prep the client for a trial-like hearing. Advocates will then go to Unemployment Compensation Hearings and represent their clients before hearing referees, which includes direct examination, cross examination, and the use of documentary evidence. Students will also write appeal briefs to the Unemployment Compensation Board of Review. EAP expects students to work collaboratively to develop best practices and support other advocates. Philadelphia Legal Assistance has a substantial state appellate case load and students may have the opportunity to draft court briefs.

This Practicum is ideal for law students who are committed to, or interested in learning more about, employment law, and who are eager to work with and represent clients. Students must commit to 6.5 hours per week for a 2-credit practicum. This includes attendance at 2 to 3 mandatory training sessions, participation in “case rounds” in which you will discuss your cases, teach, and learn from the experience of other advocates, and availability for at least two blocks of time (three hours each) Monday through Friday between 8:00 am to 4:00 pm to take clients. All other times may be fit around your schedule and can include remote work. TRANSACTIONAL PRACTICUM (CITI)

There is one spot available for second- and third-year day and third- and fourth-year evening/part time law students in this Practicum.

The experiential learning project offered with this Practicum is with Citi, one of the world’s leading digital banks. Students in this Practicum will conduct substantial research and writing on topics which may include: the regulation of payment instruments or systems, a comparative analysis of household versus small business protections, the future of privacy regulation or biometrics law, Fair Lending, the Telephone Consumer Protection Act, Fair Debt Collection Practices Act, or the Service Members Civil Relief Act.

This Practicum is ideal for students with a strong interest in researching and writing on the laws affecting financial services. This Practicum will involve weekly telephone conferences with a Citi attorney, who will guide and assist with research and writing. All research and writing will be performed remotely – not on-site at the bank. Students must commit to a minimum of 6.5 hours per week to this Practicum. ADMINISTRATIVE LAW PRACTICUM (PHILADELPHIA BOARD OF ETHICS)

There is one slot available for second-, third-, and fourth-year law students in this Practicum.

The experiential learning project offered with this Practicum is with the Philadelphia Board of Ethics. The Philadelphia Board of Ethics was created in May 2006 by amendments to the City’s Home Rule Charter. The Board interprets, administers, and enforces the ethics provisions in the Charter and City Code. These include the City’s rules governing conflicts of interest, representation in City transactions, post-employment restrictions, gifts and gratuities, interests in City contracts, political activity, financial disclosure, lobbying, and campaign finance. Via its Enforcement Staff, the Board investigates potential violations of the laws within its jurisdiction and enforces those laws through administrative adjudication or court proceedings. The Board issues formal advisory opinions and promulgates regulations interpreting City ethics laws. The Board’s General Counsel

Staff also provides informal advice, develops and delivers ethics training, and offers compliance assistance to the regulated community.

In this Practicum, the student will work closely with Enforcement Staff in furtherance of the Board's mission. This work will include assisting Staff with ongoing investigations of potential violations of the Public Integrity Laws. The student may also be asked to assist with matters in active enforcement. The student will perform legal analysis, research, and writing, and will review documents sent in response to subpoenas and formal requests. The student will learn investigatory techniques and methods and will be asked to think creatively to explore leads and develop theories of the case. The student will have the opportunity to attend regular Enforcement Staff meetings to discuss developments in their assigned matters. Depending on timing, availability, and the student's progress throughout the semester, the student may be asked to take the lead in witness interviews and other investigation events. As opportunities arise, the student may also be asked to assist General Counsel Staff in drafting advisory opinions and informal advice, delivering ethics training to City officials and employees, and drafting of proposed amendments to Board Regulations.

This Practicum is ideal for law students who are committed to, or interested in learning more about, administrative law, regulatory agencies, and municipal government. Students are not expected nor required to have taken administrative law prior to this Practicum. Students will need to commit to a minimum of 6.5 to 10 hours per week to this Practicum depending on the number of credits they prefer. Because this Practicum involves active collaboration with Board Staff, at least a portion of the hours to fulfill this Practicum (if not more) will need to be completed in-person at Board of Ethics offices, as arranged between the student and attorney supervisor. EMPLOYMENT LAW PRACTICUM (U.S. EQUAL EMPLOYMENT OPPORTUNITY COMMISSION)

There are up to three slots available for second- and third-year law students in this Practicum.

The experiential learning project offered with this Practicum is with the U.S. Equal Employment Opportunity Commission's (EEOC) Philadelphia District Office Hearings Unit. Students will have the opportunity to work alongside Administrative Judges and Law Clerks who handle civil rights cases and appeals.

In this Practicum, students will research, write, and draft briefs, decisions, and orders. Students will have the opportunity to observe local hearings and settlement conferences. The EEOC Office also partners with other federal agencies, including the Social Security Administration and U.S. Merit Systems Protection Board, offering selected students the opportunity to observe and connect with other organizations.

This Practicum is ideal for students who have a background in, and are committed to, the fields of employment law, employment discrimination, civil rights, and litigation. Preference will be given to students who have taken courses in the realm of employment law, employment discrimination, labor

law, administrative law, and civil procedure, and students who have strong writing skills and an interest in continuing to strengthen their writing. Students must commit to 10 hours per week. ATTORNEY ETHICS PRACTICUM (OFFICE OF DISCIPLINARY COUNSEL)

There is one spot available for second- and third-year law students in this Practicum.

The experiential learning project offered with this practicum is with the Office of Disciplinary Counsel of the Supreme Court of Pennsylvania (ODC). In this practicum, the student would assist with the investigation and prosecution of complaints of violations of the Rules of Professional Conduct. Under the supervision of an assigned Disciplinary Counsel, the student would be responsible for reviewing complaints of lawyer misconduct; performing legal research; writing legal memoranda; drafting chronologies; preparing exhibits for hearings; memorializing witness interviews; and participating in discussions regarding the handling of complaints and hearing strategy. The student would be immersed into interesting fact patterns and be exposed to a wide variety of law, including criminal, immigration, bankruptcy, personal injury, and domestic relations.

IMMIGRATION PRACTICUM (ESPERANZA IMMIGRATION LEGAL SERVICES UNIT)

There is one slot available for second- or third-year law students in this Practicum.

Esperanza Immigration Legal Services (EILS) was formed in 2009 to provide low-cost, non-litigation legal services to low-income immigrants and their families, including self-petitions for victims of domestic violence, green card applications, family petitions and naturalization applications.

EILS is in the heart of a low-income Latino neighborhood in North Philadelphia. EILS offers convenient, affordable and culturally accessible services to the most underserved immigrants, with a focus on the Hispanic community. EILS also offers workshops in English and Spanish to help immigrant families thrive in the United States, on topics such as financial literacy, debunking common immigration myths, and preparation for emergency situations. Finally, EILS conducts citizenship classes every summer to prepare eligible candidates for the citizenship exam.

In this Practicum, students can be expected to assist in drafting, researching and preparing immigration applications before the U.S. Citizenship and Immigration Services involving

Under the supervision of one or more AUSAs in the civil division of the United States Attorney’s Office in Philadelphia, students will engage in and observe all phases of work of the civil side of the United States Attorney's Office—to include both affirmative and defensive litigation—in subject areas including, but not limited to: torts, employment discrimination, civil rights, disability rights, environmental law, and healthcare fraud. Students will assist civil division AUSAs with a variety of casework, the nature of which depends upon the needs of each case. Assignments may include legal research, analysis, and writing; attending meetings and court hearings; assisting with witness interviews and taking/defending depositions; drafting and responding to discovery; and participating in all aspects of arbitrations and trials (including witness examination). Externs will have regular opportunities for feedback.

Objective:

Rising seas, destructive storm surges, more frequent and heavier rainfall and flooding—the impacts of climate change are present and projected to amplify in the Delaware River Basin over the next several decades. With many industrial and chemical storage facilities along the banks of the Delaware River and its tributaries, the region is increasingly vulnerable to catastrophic chemical and hazardous waste releases, threatening the health, safety, and security of local communities, many of which are already marginalized.

While flooding is common in the Delaware River Basin, many of the region’s residents, especially low-wealth and Black and Brown families, are especially vulnerable to the effects of climate change. And as extreme weather events become more frequent and severe in the coming years, this region faces an elevated risk of catastrophic hazardous chemical spills driven by flooding and other climate impacts.

To advance climate and environmental justice in these communities and strengthen public health protections, the Center for Progressive Reform will coordinate with an interdisciplinary team of legal and policy practitioners and scholars, environmental scientists, communications specialists, grassroots advocates, and technical experts to conduct groundbreaking scientific and policy research into the risks toxic chemical spills pose to regional communities; develop and implement a communications strategy to amplify findings; and undertake advocacy around the issue.

Duties and Responsibilities:

- (1) identify the industrial facilities in the Delaware River Basin at greatest risk of flooding and chemical disaster through the first-of-its kind geospatial map;
- (2) analyze the regulatory and operational gaps that contribute to these risks of major releases;
- (3) identify and engage the communities most vulnerable to harm in collaborative research, communications, and advocacy;
- (4) develop and promote dynamic and sustained multimedia public communications; and
- (5) collaboratively develop and advocate for strategies to prevent catastrophic spills.

To elevate our findings and recommendations, the intern will aid policy analyst in background research for a public report, containing at least 8-10 maps demonstrating various industrial risks to vulnerable communities in the lower Delaware River Basin and identifying policy gaps and

recommendations for Pennsylvania, New Jersey, and Delaware.

In this Practicum, students will be assigned to two district courts during their semester. They will appear before Magisterial District Judges and conduct preliminary hearings, negotiate cases (in conjunction with a supervising attorney), and interact and work with law enforcement, defense attorneys, and civilian victims and witnesses. Students will handle a variety of crimes, from misdemeanor drug and theft cases to felony assaults, robberies, and burglaries. Students receive an intensive training from trial attorneys within the office at the start of the semester and supervising attorneys are available throughout the semester to assist with case preparation and to answer any questions.

This Practicum is ideal for students with strong communication and interpersonal skills. Students must be able to be a Certified Legal Intern under Rules 321 or 322 of the Pennsylvania Supreme Court. Students must also have taken Criminal Procedure. In terms of scheduling, in addition to handling a district court’s docket of cases for one full day, students are required to spend one half day in the office, where they prepare their cases for their next court date and write an internal memo to the trial attorney on the cases they handled the previous week. The full day of court can be on a Tuesday, Wednesday, or Thursday, depending on the student’s schedule. The half day can be any day Monday through Friday. Wistar also houses a high school fellowship program, a unique Biomedical Technician Training Program and a Biomedical Research Technician Apprenticeship, which is the first of its kind in the United States. In turn, Wistar-trained investigators can be found among the leaders in every field of biomedical science. Wistar scientists have assembled state-of-the-art technologies into Shared Resources which function as engines of discovery for biomedical research initiatives at Wistar and throughout the greater research community. These resources include Bioinformatics, Biomedical Research Support, Flow Cytometry, Genomics, Imaging, Molecular Screening & Protein Expression, and Proteomics & Metabolomics.

This Practicum is an ideal opportunity for students interested in hands-on experience working in-house at a nonprofit organization in the biomedical research industry. Students will witness firsthand how lawyers can support and work to propel medical innovation forward through the power of collaboration with academic and industry partners.

Examples of tasks performed by law students include:

- Conducting legal research, analysis and writing on a broad range of topics, including regulatory and compliance requirements for the conduct of scientific research, data and privacy issues, intellectual property, corporate and nonprofit law, and labor and employment issues;
- Drafting, reviewing and revising various contracts and agreements, including confidentiality, material transfer, data use, clinical trial, government, consulting, and vendor agreements;
- Drafting and reviewing institutional policies, procedures and templates; and
- Attending meetings with internal leaders and stakeholders.

Students will need to commit to a minimum of 6.5 to 10 hours per week to this Practicum depending on the number of credits they prefer. Fully vaccinated students will be permitted to complete this Practicum in a hybrid in-office/remote work schedule. CHILD ADVOCACY UNIT PRACTICUM (DEFENDER ASSOCIATION OF PHILADELPHIA)

There are up to two slots available for third year law students in this Practicum supervised by Professor Sarah Katz.

The experiential learning project offered with this Practicum is with the Defender Association of Philadelphia. The Defender Association of Philadelphia is a nonprofit law firm created in 1934 by a group of lawyers dedicated to the belief that everyone, regardless of income, deserves the highest quality legal representation. Firmly rooted in Philadelphia for over 80 years, the Defender Association stands as the city’s vanguard for indigent defense.

The Child Advocacy Unit (CAU) is a specialty unit within the Defender Association that ensures quality representation inside and outside of the courtroom for children involved in dependency and adoption cases. The CAU was created in 1974 and contracts with the City of Philadelphia to represent children, ranging from birth to twenty-one years old, who have open dependent petitions in Family Court; are victims of neglect, physical abuse, sexual abuse, or abandonment; are truant or incorrigible; are facing mental health challenges; need additional supports as they transition into adult living or desire to re-enter the dependent system through a Resumption of Jurisdiction Motion. The CAU utilizes a multi-disciplinary approach to child advocacy by teaming attorneys and social workers to represent our young clients. They represent most of the dependent children in Philadelphia, and presently have (16) staff attorneys and (34) social workers/social service advocates.

In this Practicum, students are expected to participate in all aspects of representing our clients, who range in age from birth to 21 years of age. The practicum curriculum will focus on how to collaboratively work a case using a strengths-based lens of looking at the family and how to navigate the system for the maximum benefit to the client; our multi-disciplinary team approach (social worker/attorney); courtroom experience (permanency and dispositional hearings); developing interviewing, counseling and investigatory skills; research into community programs and services for our clients and their families; collaboration with outside agencies to meet the needs and welfare of our clients; ethical considerations inherent in our dual role of counsel and guardian ad litem; developing the appropriate tools to successfully communicate with clients and conduct legal research, analysis and writing as needed.

This Practicum is ideal for law students who are committed to, or interested in learning more about, a career advocating on behalf of children in the dependency arena and the child welfare system, or a career in public interest law. Students will need to commit to a minimum of 6.5 to 10 hours per week to this Practicum depending on the number of credits they prefer. COMPLIANCE PRACTICUM

There are multiple slots available for second- and third-year law students in this Practicum supervised by Professor Michael Donnella.

The experiential component of this Practicum is within a company in the compliance department. Compliance officers navigate the complex laws and regulations that govern the work of companies in a broad range of industries from the pharmaceutical field to health care, to the financial sector. Compliance work can include risk analysis and the creation and implementation of controls and solutions. Compliance officers examine, evaluate, and investigate eligibility for, and compliance with, laws and regulations. Students will be expected to participate in all aspects of compliance work including the investigation, research, and analysis of eligibility and compliance. Students will be expected to identify issues, theories, strategies, and solutions. Past participating companies include Aramark, Temple University Health System, CHOP, and Temple University Office of Ethics and Compliance.

Temple Law’s Compliance Practicums are ideal for law students who are interested in learning more about how to analyze risk, evaluate eligibility and compliance, and work for some of the top companies in the region. Students will need to commit 10-15 hours per week. PUBLIC INTEREST PRACTICUM (PHILADELPHIA LEGAL ASSISTANCE— CONSUMER HOUSING UNIT)

There are up to two slots available for second-, third- or fourth-year law students in this Practicum.

Philadelphia Legal Assistance (PLA) is a non-profit legal services agency in Philadelphia. Funded by the Legal Services Corporation, PLA provides free legal assistance to low-income Philadelphians on a variety of legal topics, including family law, tax assistance, and homeownership.

The priorities of the Consumer Housing Unit include representing low-income homeowners facing the imminent threat of loss of homeownership as a result of mortgage and real estate tax foreclosure and/or mortgage servicing problems. As part of this work, the Consumer Housing Unit provides additional assistance to homeowners with tangled titles; meaning, Philadelphians who own part or all of a property, but do not have their name on the deed. Common scenarios include inherited homes that are subject to family disputes and properties that were fraudulently transferred.

Students in this practicum will focus on resolving tangled titles for clients, and will have the opportunity to assist Consumer Housing Unit attorneys with some or all of the following:

- Searching public records databases (using Lexis access), NewsBank's obituaries, SS Death Index, etc. for record owners and heirs
- Preparing FOIA requests for forwarding address information from USPS
- Searching Philadelphia Courts Civil Docket Access for property liens and active cases
- Drafting complaints
- Drafting deeds

This Practicum is ideal for students with an interest in housing justice, property, trusts and estates, and/or public interest law. Students will need to commit to a minimum of 6.5 to 10 hours per week to this Practicum depending on the number of credits they prefer. JUDICIAL INTERNSHIP PRACTICUM (HONORABLE J. SCOTT O’KEEFE, CRIMINAL DIVISION)

There are two slots available for second- and third-year law students in this Practicum.

The experiential learning project offered with this Practicum is with the Honorable J. Scott O’Keefe, Philadelphia Court of Common Pleas, Criminal Division. Judge O’Keefe presides over homicide cases. Practicum students will have the unique opportunity to witness the inner workings of homicide cases in a courtroom setting. Students will observe homicide trials, which often involve video evidence of the crime scenes. Students will also observe sentencings, which often include emotional testimonies from the families of the victims. The experiences can be emotionally

challenging but provide invaluable insights into the complexities of criminal law and the impact of violent crimes on individuals and society.

In this practicum, students will closely observe homicide trials, and during sidebar or backroom conferences, students will witness legal arguments and objections from both prosecuting and defense attorneys. Students may also have the opportunity to visit other courtrooms to observe and learn from diverse judicial styles. Students will trial strategies, legal tactics, and how different judges handle cases.

This Practicum is ideal for law students who are committed to, or interested in learning more about, criminal law, particularly homicide cases. (Please note that due to the emotionally charged nature of the cases and the exposure to sensitive content, this practicum may not be suitable for everyone.) Students will need to commit to a minimum of 6.5 to 10 hours per week to this Practicum depending on the number of credits they prefer. **CRIMINAL LAW PRACTICUM (PHILADELPHIA DISTRICT ATTORNEY’S OFFICE-
BRADY DIVISION)**

There is one slot available for a second-, third-, or fourth-year law student in this Practicum supervised by Professor Jules Epstein.

The experiential learning project offered with this Practicum is with the Philadelphia District Attorney’s Office new *Brady* Unit. The student will work on issues surrounding a prosecutor's office's compliance with the constitutional requirement to turn over all favorable, material evidence to the defense prior to trial pursuant to *Brady v. Maryland*. *Brady* violations produce wrongful convictions, burdensome litigation, expensive legal settlements, and renewed trauma to victims—the District Attorney is firmly committed to preventing them.

The student will work directly with a special advisor to the District Attorney (as well as other ADAs) to examine past and present Philadelphia DAO *Brady* practices and research other jurisdictions' approaches to ensuring prosecutors' full compliance with *Brady*.

Interested students should have already taken Criminal Procedure II or a comparable course (e.g. Death Penalty). LABOR LAW PRACTICUM (U.S. DEPARTMENT OF LABOR, OFFICE OF THE SOLICITOR)

There are multiple slots available for second- and third-year law students in this Practicum.

The experiential learning project offered with this Practicum is with the U.S. Department of Labor's Office of the Solicitor, Philadelphia Regional Office. The Philadelphia Regional Solicitor's Office is responsible for most civil trial litigation and legal support for the U.S. DOL in several states including Pennsylvania, West Virginia, Delaware, and the District of Columbia. The Office is primarily involved in the enforcement of a number of federal laws that ensure that our region's workers are employed in safe and healthy workplaces, are paid at least the federal minimum and overtime wage rates, and are treated without regard to race, color, sex, national origin, religion, or status as a whistleblower, a person with disability or a veteran.

In this Practicum, students will be engaged in an immersive litigation experience and be permitted a "deep dive" into complex and compelling labor cases involving FLSA, OSHA, MSHA, ERISA, and whistleblower cases, among others. Students will perform legal research, draft motions, help propound and respond to discovery, help prepare for taking and defending depositions, and prepare for and participate in settlement conferences, various in-court motions practice and proceedings, pre-trial conferences, and trial.

This Practicum is ideal for second- or third-year law students who are committed to, or interested in learning more about, litigation and labor law. Students must commit to 10 hours per week. COMPLIANCE PRACTICUM (PENNSYLVANIA OFFICE OF STATE INSPECTOR GENERAL)

There is one slot for a second- or third-year law student in this Practicum supervised by Professor Michael Donnelly.

First formed by Executive Order 1987 by Governor Robert P. Casey and now codified by Act 29 of 2017, the Pennsylvania Office of State Inspector General's (OSIG) Southeast Regional Office's (801 Market Street, Philadelphia) mission is to "deter, detect, prevent, and eradicate fraud, waste, misconduct and abuse in the program, operations and contracting of executive agencies." The OSIG has two investigative bureaus: the Bureau of Fraud Prevention and Prosecution (BFPP) and the Bureau of Special Investigations (BSI). BFPP assists the Department of Human Services (DHS) with investigation, prosecution and collection activities for the public benefit programs it administers while BSI investigates allegations of fraud, abuse and misconduct in state agencies under the Governor's jurisdiction. In this Practicum, the student will work closely with attorneys on every aspect of an investigation. This includes, but is not limited to:

- Consulting with supervising attorney, and in collaboration with BSI investigators and Investigation Managers, work to identify fraud, waste and abuse within state programs and agencies and investigate alleged misconduct by Commonwealth employees;
- Assisting supervising attorneys and BFPP investigators with the investigation and subsequent prosecution of welfare fraud;
- Provide research on applicable management directives, statutes and other laws implicated in an investigation; and
- Attend meetings and interviews related to the case.
