## Admission by Examination

For applicants to be admitted to practice by examination, applicants must:

- Submit the necessary application form(s) and fee(s) to the jurisdiction
- Sit for and take the bar exam in that jurisdiction
- Satisfy the jurisdiction's character and fitness and other admission requirements (e.g.: MPRE)
- Complete any jurisdictionspecific law component(s) required

# Application Deadlines and Fees

- Check with your jurisdiction's governing body for bar admissions for relevant deadlines, fees, and requirements
- Application fees can be costly!
  - Fees may increase with later deadlines
  - Additional fees for computerbased testing, transferring MPRE scores, etc.

#### **Bar Exam**

#### What is the Bar Examination?

- A test of <u>minimal competence</u>
  - Average minimum pass score approximately 65%-70%
- Multi-day, closed-book examination to test your ability to think and reason like a lawyer
  - Typically administered during the last week of July and/or February
- Tests the black letter law
- Does not test:
  - Specific case law
  - Policy considerations

#### Do I need to take the bar exam?

#### Yes if:

 You have a job offer in hand that requires you to be admitted to practice law

#### No if:

- You do not plan on practicing law
- You have an alternative career or JD Advantage job offer in hand

#### When do I need to take the bar exam?

- The first administration after graduation from law school
  - July for most graduates
- Reasons to defer taking the bar exam to a subsequent administration
  - Working full-time in a job that does not require you to be admitted to practice
    - E.g.: law-related job, non-law-related job, judicial clerkship
  - External Obligations/Responsibilities
  - Burnout
  - Insufficient time to prepare for the exam adequately

#### Where to Take the Bar Exam: Things to Consider

- Post-Grad Employment
  - Employment requirements
  - State v. Federal work
- Long-Term Goals
  - Where do you want to live and/or work?
- Minimum Pass Score (i.e.: "cut score")
  - Relevant when considering among UBE Jurisdictions
- Other Avenues to Bar Admission


#### **Types of Bar Exams**

- Uniform Bar Exam (UBE) <a href="https://www.ncbex.org/exams/ube">https://www.ncbex.org/exams/ube</a>
  - o E.g.: PA, NJ
- UBE & Additional Jurisdiction-Specific Requirements
  - E.g.: NY
- Jurisdiction-Specific Exams
  - E.g.: CA, FL, DE

#### What is the UBE?

- Uniformly administered and scored bar exam that results in portable score
- Bar candidates who take the UBE may transfer their scores to seek admission in other UBE jurisdictions within a certain amount of time after the scores were earned
- Administered twice per year
  - Last Tuesday and Wednesday of February and July

#### **Jurisdictions that have Adopted the UBE**



#### **UBE Test Components**

- Multistate Performance Test (MPT) Tuesday, 3 hours
  - Two 90-minute "closed universe" assignments: simulated case files testing fundamental lawyering skills
- Multistate Essay Examination (MEE) Tuesday, 3 hours
  - Six 30-minute essays
- Multistate Bar Examination (MBE) Wednesday, 6 hours (two 3-hour sessions)
  - 200-question multiple-choice exam

# Character & Fitness and Other Requirements

#### Character & Fitness

#### **Overview of Character & Fitness**

- Demonstration of character and fitness is among the essential elements required for bar admission
- Background investigations are part of the admission process for all jurisdictions
- Requirements, deadlines, and processing times vary among jurisdictions
  - Get familiar with your jurisdiction's requirements!
- Primary purpose: to protect the public
- Onus is on applicant to prove good moral character
- Candor is paramount

#### What can I do now?

- Familiarize yourself with the character & fitness questions for the jurisdiction(s) in which you wish to be admitted to the bar
  - Get a sense of what type of supporting documents you may need
- Start compiling address history and employment history
  - Go back as far as the jurisdiction that requires the longest history
  - E.g.: PA (5 years) and NJ (10 years) compile 10-year history now
- If you think you need to amend your law school application, do so now!

# Multistate Professional Responsibility Exam (MPRE)

#### **MPRE Basics**

- Two-hour, 60-question multiple choice exam
- Tests knowledge and understanding of established standards related to the professional conduct of lawyers
  - Does not test personal ethics
  - Not just "common sense"
- Required by all but two jurisdictions
  - Not required in Wisconsin or Puerto Rico
  - Connecticut and New Jersey will accept successful completion of law school course on professional responsibility in lieu of MPRE score
- Each jurisdiction sets their passing score and time limitations (if any)

#### **MPRE Registration Process: 2-Step**

- Step 1: Register through NCBE
  - Create an NCBE Account (if you haven't done so already)
  - If needed, <u>apply for MPRE Testing Accommodations</u>
  - Register for the MPRE through your NCBE Account
- Step 2: Schedule test through Pearson VUE
  - Receive Authorization to Test email from Pearson VUE
  - Schedule test and pay fee through Pearson VUE within 48 hours of receiving email and before registration deadline
  - Early is best! Waiting to schedule your test closer to the registration deadline may result in fewer local testing sites available

#### When should I take the MPRE? Things to Consider

- Offered 3 times per year: March, August, and November
- Does your jurisdiction have certain time limitations?
  - O Do you need to take the MPRE before you apply for the Bar Exam?
  - o Is there an expiration on your score?
- Have you taken Professional Responsibility yet?
- When do you plan on taking the bar exam?
- Do I need to be admitted to practice immediately?

#### **How do I prepare for the MPRE?**

- Free prep courses through commercial bar prep companies
  - Opportunity to try different platforms to see what courses you may prefer for bar prep
  - o e.g.: <u>Barbri</u>, <u>Helix</u>, <u>Kaplan</u>, <u>Quimbee</u>, <u>Themis</u>
- Supplemental Practice Materials/Tests
  - Use NCBE licensed questions when possible!
  - May require an additional fee
  - NCBE Study Aids for Purchase

#### How do I send my MPRE score to the BOLE?


- When you register for the MPRE, you will be asked to indicate the jurisdiction to which you want your score reported. NCBE will report your MPRE score to that jurisdiction about 5 weeks after the exam.
  - If you recently registered for or took the MPRE, you can see the jurisdiction you selected by viewing the Summary of Request for Test Authorization in your <u>NCBE Account File Cabinet</u>
- If you want your MPRE score reported to additional jurisdictions, you must submit a request to NCBE for an MPRE Score Report through your NCBE Account.
  - As of January 2024, the NCBE Score Services Fee is \$30

# Jurisdiction-Specific Law Component

#### **Jurisdiction-Specific Law**

- UBE jurisdictions may require completion of a course, test, or some combination <u>separate from</u> the UBE
- Completion may be required before admission or within a certain amount of time after admission.
- Jurisdiction-specific components typically require for all candidates regardless of whether testing or transferring UBE score

### UBE Pre-Admission Jurisdiction-Specific Law Components



#### Pre-admission component:

Alabama, Arizona, Maryland, Massachusetts, Michigan, Missouri, Montana, New Mexico, New York, Ohio, South Carolina, Tennessee, Texas, Virgin Islands, Washington

#### No pre-admission component:

Alaska, Arkansas, Colorado, Connecticut, District of Columbia, Idaho, Illinois, Indiana, Iowa, Kansas, Kentucky, Maine, Minnesota, Nebraska, New Hampshire, New Jersey, North Carolina, North Dakota, Oklahoma, Oregon, Pennsylvania, Rhode Island, Utah, Vermont, West Virginia, Wyoming

## **Admission by Score Transfer**

- Passing score in jurisdiction required
  - Even if your score wasn't high enough to "pass" where you sat for the exam
- Need an official
   UBE transcript from NCBE to be sent to the jurisdiction
- Still need to submit the necessary application form(s) and fee(s), satisfy the character and fitness and other admissions requirements, and complete any jurisdictionspecific law component(s) for the jurisdiction
