C. ELIGIBILITY:

All applicants must be a resident of Cumberland County for at least one year prior to the date of their application. The Scholarship Committee reserves the right to request proof of residency (i.e. current driver's license, utility bill, etc.)

D. REQUIREMENTS:

1. Applicants from Law Schools:

- a. Applicants must be enrolled in and intending to complete law school on either a full time or part time basis.
- b. Applicants must have a passing grade point average, where the highest grade is an A and the lowest grade is an F, and be in good standing, having no disciplinary issues, with the law school.
- c. Applicants must provide the Committee with a copy of their official transcript. Students who will be entering their first year of law school must provide a copy of their official college transcript and proof of acceptance into law school.
- d. Applicants must return their applications no later than the return date set each year by the Committee. Late and/or incomplete applications will not be considered.
